VOTE YES ON THE COMMUNITY CLEAN WATER INITIATIVE



Our board voted to endorse the countywide initiative to protect clean water through a March vote of property owners in Contra Costa County to place a tax of \$12-\$22 on property tax bills. We will make a statement endorsing the measure at a Contra Costa County Board of Supervisors hearing on Tuesday, February 7. The tax would last ten years.

The money goes to each local community and can only be used in that community for the specified purpose of capturing, cleaning, and using rainwater to irrigate local parks and landscaping. The water is polluted by development and consequent pollutants, toxic chemicals, and bacteria and viruses. Retaining and cleaning this run-off will protect our streams, bay, and ocean. The tax is indexed for inflation. The tax is based on the amount of paved land, so it will be more for businesses and larger buildings. All tax money will remain under local control, and expenditures will be supervised by independent citizens oversight and mandatory audits. Our League positions for time-limited taxes are met by this measure, and it is consistent with our positions on water and protecting the environment.

We urge all property owners in Contra Costa to vote yes on their mail-in ballots, which will go out in the week of February 21. All ballots must be mailed or hand delivered to the Elections office at 555 Escobar in Martinez so that they are in the county's possession by April 6, 2012, at 5:00 p.m.

NOMINATING COMMITTEE



The Nominating Committee—comprised of Martha Goralka, Chris Coons, Joan Lautenberger, Jeanne Melaugh, and Gwen Watson—is beginning the task of building the slate of directors and chairs for 2012-2013. Smartvoter.org is for every voter who can access the internet (via PC or smartphone). Voters can enter their address to see a personalized ballot with links to candidates' information. The goal is to offer the complete list of all contests on each ballot, including local offices. Accordingly, we invite all local candidates to post their information (this service is free).

The Smart Voter team needs people to help with any of the following:

Non-computer jobs

- Assemble letters to candidates at a "mailing party" (during the day)
- Call candidates to ask if they received the letter, and answer questions (script provided)
- Remind candidates who have not responded
- Provide publicity

Computer jobs

- Link news articles to each race page (instructions provided)
- Read information candidates have submitted, and determine whether it meets Smart Voter appropriateness criteria
- Enter local ballot measures

SCHOOL FINANCE

In an ongoing process, the California Legislature and the Governor of our state decide how much money will be divided between the County Offices of Education and the California Department of Education and among the school districts. Where do the dollars to pay for this come from? The sources are:

- Federal, about 11%
- State, about 61% (generated by business and personal income taxes, state taxes, and some special taxes)
- Local property taxes (about 21% of all funds)
- The Lottery, less than 2% or about \$150 per pupil
- Miscellaneous resources, about 6% (special election parcel taxes, contributions from foundations and businesses, and interest from investments)

The funds are distributed in a formula of two-thirds for general purposes and one-third for special purposes or categories of students. The school districts—by order of the California Legislature—must adhere to the established revenue limits, but the lottery dollars are not to be targeted for a special purpose. So, there is a little wiggle room. On the other hand, “categorical aid” must be used for the specific program for which it qualified. With the uncertain funding all this year, it is hard to know what the future holds.

LEAGUE SUPPORTS DEATH PENALTY ABOLITION INITIATIVE



Our board joins the LWV of California in supporting a proposed ballot measure that would abolish the death penalty in California and transfer all prisoners on death row to state prisons for life, saving the state \$1 billion over four years. The coalition drafting this measure is using both paid and volunteer signature gatherers to get it on the ballot, and they are close to their 750,000-signature goal. The deadline is the middle of February. If you know of group meetings or other events where signature gathering could be done efficiently, or if you would like to help, please let us know. Some of us will be collecting signatures in BART stations in our area in the next week during the late afternoon commute hours.
